WPI's Right to Know

The Jeanne Clery Disclosure of Campus Security Policy and Campus Crime Statistics Act was signed into law in November 1990 (known at the time as the Student Right to Know and Campus Security Act). It requires institutions participating in student financial aid programs under Title IV of the Higher Education Act of 1965 to disclose information about campus safety policies and procedures and to provide statistics concerning certain crimes that occurred on or near campus. In compliance with the act, the WPI Police Department publishes and distributes this information each year in its "Right to Know" brochure. Each fall, brochures are placed in all campus mailboxes (students, staff, and faculty). In addition, enrolled students and current employees may review a copy of the "Right to Know" brochure at www.wpi.edu/+police. Printed copies may be obtained by calling 508-831-5433.

Campus Police

The WPI Police Department is located at Founders Hall, lower level, about two blocks from the campus quadrangle. It operates 24/7, year-round. WPI police officers are commissioned in accordance with the provisions of Chapter 22C, Section 63, of the Massachusetts General Laws and have full law enforcement authority in and upon all property owned, occupied, or used by WPI.

All newly appointed police officers are graduates of a police academy

conducted or sanctioned by the Massachusetts State Police or the Massachusetts Criminal Justice Training Council. Recruit training academies consist of several months of full-time, in-depth training in all aspects of police operations and are followed by



several weeks of field training under the close supervision of a campus police supervisor. Annual in-service refresher training is provided to all officers, and officers are frequently assigned to attend in-depth training in a variety of specialized topics:

- Crime Prevention Theory
- Investigation of Sexual Assaults
- Investigation of Bias-motivated Crimes
- Rape Aggression Defense (RAD)
- Defensive Tactics
- OSHA Regulations
- Firearms Training
- ICS/NIMS (Incident Command)

Police Services and Crime Prevention

The WPI Police Department believes it is more beneficial to prevent crimes than to react to them after the fact. A primary vehicle for accomplishing this goal is the department's crime prevention strategy, a program based on the concepts of eliminating or minimizing criminal opportunities whenever possible, and encouraging students and employees to be responsible for their own security and the security of others.



This strategy is also based on a multilevel approach that includes proactive area patrols of the campus, crime prevention education and training, building and area surveys to assess risk, and recommended compensatory measures.

Interagency Relationships

The WPI Police Department maintains a close working relationship with the Worcester Police Department, state and federal law enforcement agencies, and other agencies of the criminal justice system. Crime-related reports and statistics are routinely exchanged.

The Command and Supervisory staff of our department is encouraged to participate in professional associations that foster increased proficiency in their areas of responsibility. Members of the staff maintain active memberships in the following associations:

Reporting Criminal Incidents and Other Emergencies

In compliance with the Clery Act (*see page 2*), WPI requires that employees and students promptly report all emergencies and criminal activity (within 24 hours of becoming aware). To assist in this process, WPI has strategically placed 55 Emergency Phones (recognized by their blue lights) throughout the campus. These phones ring directly into the campus Police Department, automatically registering the location of the caller.

A crime or other serious incident may also be reported at the campus police station, Founders Hall, lower level. An incident report is then completed by WPI Police personnel in accordance with departmental policies and procedures.

The WPI Police Department, in cooperation with local law enforcement agencies, investigates all reported criminal activity. Anyone with information regarding a crime or other situation that poses a threat to the campus community should notify campus police immediately.

The Dean of Students Office, Residential Services, and the Counseling Center can also assist students in reporting serious incidents. The Office of Human Resources is available to assist all employees with issues of concern and outside support. The following numbers are provided to assist you in reporting incidents of crime:

Safety Notifications

In the event a situation arises, either on or off campus, that constitutes an ongoing or continuing threat, a campus-wide safety notification will be issued. The notification will be posted on the Emergency Preparedness website in conjunction with an email advising the community of the posted notification. Depending on the particular circumstances of the crime, especially in situations that could pose an immediate threat to the community and individuals, the WPI Police may also post a notice on campus electronic bulletins and/or on the WPI Police website. In some instances a copy of the notice may be posted in each residence hall and may be disseminated to fraternities and sororities.

Anyone with information warranting a safety notice should report the circumstances immediately, either by phone, 508-831-5555, or in person to the campus Police Department, Founders Hall, lower level. Safety notifications of situations that may pose a threat to others are generated from reports made to campus police authorities as identified by WPI, the WPI Police Department, and/or local police agencies having concurrent jurisdiction (see Interagency Relationships section).

Emergency Preparedness

WPI's need to be prepared for emergencies is ongoing. Through proactive training, drills, and involvement with organizations such as the International Association Campus Law Enforcement Administrators (IACLEA), we are continuing to build a community that is ready and willing to support and protect the campus. Through WPI's Telephone/Email Notification System (Connect-ED), a mass notification system has been implemented that allows authorized WPI officials to send news and instructions simultaneously to individuals through landline phones, cell phones, text messaging, and email within moments of the critical incident.

WPI Police Daily Log

Dispatchers at the campus police station document all calls for service in the police daily log—a chronological record of all crimes reported to the WPI Police, as well as the names of all persons arrested. Daily logs are available for public viewing during regular office hours; copies are available within two business days of request.



Monitoring and Recording Criminal Activity

On campus: Our computerized incident report system assists officers in documenting reports of crimes, injuries, emergencies, unusual events, or suspicious activity on campus, and facilitates the collection of monthly and annual crime statistics. The WPI Police Department is linked nationwide through the LEAPS/NCIC/CORI Law Enforcement Network, allowing the department access to criminal activity, motor vehicle history/information, and priority communication between law enforcement agencies. The Worcester Police Department provides campus police with statistics for crimes committed in any building or on any property owned or controlled by the university located within a reasonably contiguous area used by

by WPI in direct support of, or in a manner related to, the university's educational purposes.

Off campus: The Worcester Police Department provides campus police with statistics for crimes committed on public property located within the same reasonably contiguous geographic area of the university (i.e., sidewalk, street, thoroughfare, parking facility) and is adjacent to a facility that is owned or controlled by the university if the facility is used by WPI in direct support of, or in a manner related to, the university's educational purposes. It also provides statistics for crimes committed in any building or property owned or controlled by student organizations that are recognized by WPI (see Crime Statistics section).

When a serious crime occurs on campus, the Worcester Police Department is contacted and works closely with campus police in a coordinated investigative effort. Depending upon the nature of the crime, State Police specialists may be contacted and requested to assist in the investigation.

Access to Academic Buildings, Other Facilities

Access to campus facilities and grounds is a privilege extended to students, faculty, staff, and guests. WPI encourages an open environment, with limitations, to assure adequate protection of all members of the university community. Except for residence halls, most campus facilities are accessible to community members during the days and evenings that classes are in session.

Specific hours of operation are determined by respective department heads (faculty or administrative). Access to these facilities after hours (and when classes are not in session) is in accordance with the access control policies established by the designated department head and the WPI Police Department. Faculty, staff, and students must receive proper and advanced authorization when these facilities are closed.

Most of WPI's students, faculty, and staff use keys or keycards to access buildings and rooms on campus. Lost or stolen keys should be reported to the WPI Police Department immediately. A report will then be documented and forwarded to the WPI locksmith. Keys issued are nontransferable.

WPI will prosecute unauthorized persons found trespassing on university property or found in possession of unauthorized keys, keycards, or access codes.

Residential Services Program

WPI's Residential Services staff provides resident students with information concerning security and safety policies and procedures, including guest access policies, in its Residential Hall Living brochure.

During holidays and other periods when classes are not in session, some or all residence facilities are closed. Students authorized to live on campus during those times must register with the Residential Services Office and the WPI Police Department. Safety and security policies and procedures that apply during the academic school

and security policies and procedures that apply during the academic school year are in effect during these periods, as well.

Security in the residence halls is an extremely important issue. Resident students play a key role in ensuring these areas are safe and secure, since they know best who belongs in the residence halls, and who looks out of place. They serve as the eyes and ears for their fellow students and the WPI community. If something looks suspicious to them, they're advised to call the WPI Police Department. Although resident students cannot assume that everyone who approaches the door of a residence hall is a student or resident, they should avoid holding doors to let others enter or from propping doors open for any reason.

Students Traveling Abroad

Students at WPI project centers must adhere to health and safety instructions distributed through the Interdisciplinary and Global Studies Division (IGSD) and reviewed at mandatory orientations. Faculty and students involved with individually sponsored residential off-campus project activity must adhere to the appropriate health and safety policies as outlined by the requirements for Individually Sponsored Residential Projects. Consult the IGSD or the Office of the Provost for more information.

We encourage project center students to contact the appropriate police jurisdiction at their respective sites to learn about issues like personal safety, security, crime problems, and statistics. IGSD: 508-831-5547, Provost: 508-831-5222

Maintenance Service

Facilities Services provides maintenance of campus buildings and grounds. WPI police officers routinely check the campus and report unsafe conditions to Facilities Services. However, if you have concerns for personal safety and property protection (i.e., inoperative locking hardware, exterior lighting, steps and handrails, unsecured equipment, hazardous conditions), you may alert Facilities Services staff via the work-order system or by calling 508-831-5500.

Fire Safety

The WPI Police and Facilities Services departments work closely with the Worcester Fire Department to ensure that the university is in compliance with applicable fire and life safety codes and standards. Egress drills and educational training programs in fire safety and prevention are offered to all faculty, staff, and students.

Emergency Medical Services

The WPI Health Center, located in Stoddard C, 32 Hackfeld Road, is open Monday through Friday, 8 a.m. to 5 p.m. A physician can be reached at 508-831-5520. **After hours, an MD can be reached at 508-334-8830 (identify yourself as a WPI student).**

Campus police are trained as first responders and are certified in cardiopulmonary resuscitation. During the academic year, a group of student certified first responders volunteer their services to the community by assisting WPI police with medical emergency calls. Sick or injured persons are transported by a local ambulance service to a nearby hospital if determined necessary. *Ambulance transport charges may be billable to your insurance carrier. Individual policies may vary.*

Policy Statement on Sexual Assault

WPI values the health and safety of every individual on campus and expects its community members to treat all people with respect and dignity. The university recognizes the critical need to develop policies and programs that support victims/survivors and encourages them to report sexual assaults/rape (forcible and non-forcible) to the university staff. WPI is committed to providing a working and learning environment free of all forms of abuse, harassment, or coercive conduct and to offering the educational programs designed to meet these goals.

Note: The *WPI Campus Planner and Resource Guide* lists specific criteria and sanctions on sexual assault and rape and WPI's policy on sex offenses.

Whether or not you ultimately choose to pursue criminal charges, you may contact the WPI Police Department for advice about sexual assaults. Our police officers are available 24 hours a day and are professionally trained and experienced in dealing with sexual assaults and rape. They are sensitive to the feelings you may be experiencing and will be supportive in assisting you with options and resources.

The Worcester Police Department's Detective Division is the primary investigatory agency of crimes of this nature that are committed off campus. WPI police handle on-campus investigations of crimes of this nature and may work in collaboration with other local, state, and federal agencies, if necessary.

The Student Life Office also assists students who are victims of an alleged sexual assault and who wish to change their academic and/or living situations.

Always remember, the choice is yours. Just because you notify the police does not necessarily mean you have to prosecute the assailant(s). If you choose not to press criminal charges, you have other options available for reporting the assault.

Disciplinary Action

If you have been sexually assaulted, you are encouraged to discuss the matter with one of the Judicial System's case officers, located in the Dean of Students Office. This allows you a chance to discuss options and review procedures should you decide to file a formal complaint to be handled by the Campus Judicial System. This discussion does not obligate you to pursue official action.

In accordance with the requirements of the *Student Right-to-Know and Campus Security Act* as amended in 1992, in any campus judicial case alleging some form of sexual assault, the accuser and the accused are entitled to the same opportunities to have others present during a campus disciplinary proceeding, and both the accuser and the accused shall be informed of the outcome of any disciplinary proceeding brought alleging a sexual assault.

Counseling Services

Members of WPI's professional counseling staff are available to intervene in a crisis situation and provide free, safe, confidential support during difficult times. They can inform you of common reactions to



reactions to crisis and discuss coping methods that may assist you immediately following the assault and at a later time. Talking about your concerns with one of these counselors may help you sort through your feelings and help you decide what, if any, course of action is right for you.

Sexual Offender Registry Information

The WPI Police Department receives printed information from the Worcester Police Department relating to Level 2 and Level 3 sex offenders. The Sex Offender registry information may not be complete, nor current, as it relates to information about all sex offenders in the Commonwealth of Massachusetts. However, the Worcester Police Department sends updates periodically as information is received from the state. Information is available for review at the WPI Police Department, Founders Hall, lower level.

Further Cautionary Information

Sex Offender Registry information shall not be used to commit a crime or to engage in illegal discrimination or harassment of an offender. Any person who uses information disclosed pursuant to M.G.L. c.6 s.178C-178P for such purposes shall be punished by not more than two and a half (2½) years in a house of correction or by a fine of not more than one thousand dollars (\$1,000) or both (M.G.L. c.6 s.178N). In addition, any person who uses registry information to threaten to commit a crime may be punishable by a fine of not more than one hundred dollars (\$100) or by imprisonment for not more than six (6) months (M.G.L. c.275 s.4).

If a Level 3 Sex Offender is not in compliance with his or her registration requirements, the board will not provide that offender's home or work address because the offender has failed to verify or provide the board with a correct address as the law requires. The detail page will display the word VIOLATION in the county section of its Web page.

An offender who is in VIOLATION may be subject to arrest and prosecution pursuant to M.G.L. c.6 s.178H & 178P. If you have any information regarding the whereabouts of a Level 3 Sex Offender who is in VIOLATION, contact your local Police Department or the Massachusetts Sex Offender Registry Board at 978-740-6400.

If further information is needed, contact the Commonwealth of Massachusetts Sex Offender Registry Board at 978-740-6400 between the hours of 8 a.m. and 5 p.m., Monday through Friday.

WPI Alcohol and Other Drug Policy, Statement of Behavioral Expectations

WPI seeks to establish an environment—personal, social and academic—that supports its commitment to an excellent undergraduate and graduate education. WPI encourages the student's maturity into early adulthood and discourages experiences that may compromise such maturity. The university will support timely educational programs as resources for the student's personal development.

WPI recognizes that drugs and alcohol constitute significant personal and social problems within society in general and colleges in particular. WPI supports, promotes, respects and expects adherence to federal and state laws regarding alcohol and drugs.

WPI demonstrates its values concerning an excellent education, encouragement of a student's maturity, and federal and state laws regarding drugs and alcohol in a variety of ways. Faculty, alumni, staff, and other members of the WPI community are expected to serve as positive role models, especially with respect to the responsible use of alcohol. WPI promotes and presents, to all members of the community, drug and alcohol awareness programs that address issues proactively. More specifically, WPI presents a multitude of programs on student development; provides programming to students on developing the skills necessary to be effective at WPI and in life; empowers students who choose not to drink; offers easy access to services that are intended to assist students who have alcohol or drug problems; and provides students with the opportunity to choose a substance free living and learning experience.

The WPI community is composed of students, their families, faculty, staff, and alumni. The entire community must assume responsibility for providing a climate which represents personal rights, federal and state laws, and models of appropriate behavior as defined

rights, federal and state laws, and models of appropriate behavior as defined by the Drug and Alcohol Policy.

WPI Drug and Alcohol Policy

In accordance with the Drug-Free Schools and Communities Act Amendment of 1989, and the laws of the Commonwealth of Massachusetts, WPI prohibits the unlawful possession, use and/or distribution of illicit drugs and alcohol on its property and/or as part of its activities.

1. Students under the age of 21 may not possess, consume, transport, or be served alcohol.
2. Kegs, beer balls, bulk containers, or any other common sources of alcohol are not permitted on WPI owned, operated, or affiliated property at any time.
3. Students may not possess, use, or distribute illicit drugs or possess drug-related paraphernalia.
4. It is a criminal offense, punishable by up to a year in jail and \$2,000 fine, for any person to furnish any alcoholic beverage to a person less than 21 years. According to Massachusetts state law, "furnish" means to knowingly or intentionally supply, give or provide to or allow a person less than 21 years of age to possess alcoholic beverages on premises or property owned or controlled by the person charged.

Student members of the WPI community who are in violation of this policy are subject to local, state, and federal law as well as disciplinary adjudication under the WPI Code of Conduct, the WPI Residence Hall Policy, and/or the WPI Greek System Policy. The various sanctions outlined in Article I, Section D of the Constitution of the WPI Campus Judicial System are applicable to students found responsible for violating WPI's Drug and Alcohol Policy.

Dangerous and/or Binge Drinking

The WPI Code of Conduct guarantees certain rights and responsibilities to members of the WPI community. Among those responsibilities is the expectation that no member of the community shall impair the well being of another community member or themselves. Dangerous drinking and/or binge drinking is an example of behavior that can be injurious and is prohibited under the WPI Campus Code of Conduct.

Education

Education and counseling services are available to all members of the WPI community. Students, faculty and staff are encouraged to refer persons troubled by alcohol and/or drug use to the WPI Counseling and Student Development Center or to one of the various community support services available in or around Worcester.

Please refer to the *Campus Planner and Resource Guide* for on- and off-campus resource information.

Criminal Offenses Reported to WPI Police

Campus: Any building or property owned or controlled by WPI within the same reasonably contiguous geographic area and used by the university in direct support of, or in a manner related to, its educational purposes. This includes residential halls, any building or property owned by WPI but controlled by another person, those frequently used by students, and those that support university purposes, such as food or retail vendors.

Non-Campus: Any building or property owned or controlled by student organizations recognized by WPI, and any building or property owned or controlled by the university that is not within the same reasonable contiguous area.

Public Property: The area that is within the same reasonably contiguous geographic area of the university, or is adjacent to a facility owned or controlled by WPI and used in a manner related to its educational purposes.

Criminal Homicide:

Murder—the willful (non-negligent) killing of one human being by another.

Manslaughter by Negligence—the killing of another person through gross negligence.

Sex Offenses (Forcible):

Forcible Rape—the carnal knowledge of a person, forcibly and/or against that person's will, or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her temporary or permanent mental or physical incapacity (or because of his/her youth).

Forcible Sodomy—Oral or anal sexual intercourse with another person, forcibly and/or against that person's will; or not forcibly against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

Sexual Assault With an Object—the use of an object or instrument to unlawfully penetrate, however slightly, the genital or anal opening of the body of another person, forcibly and/or against that person's will; or not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental or physical incapacity.

Forcible Fondling—the touching of the private body parts of another person for the purpose of sexual gratification, forcibly and/or against that person's will; or, not forcibly or against the person's will where the victim is incapable of giving consent because of his/her youth or because of his/her temporary or permanent mental incapacity.

Sex Offenses (Non-forcible):

Incest—non-forcible sexual intercourse between persons who are related to each other within the degrees wherein marriage is prohibited by law.

Statutory Rape—non-forcible sexual intercourse with a person who is under the statutory age of consent.

Robbery—the taking or attempting to take anything of value from the care, custody, or control of a person or persons by force or threat of force or violence and/or by putting the victim in fear.

Aggravated Assault—an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault usually is accompanied by the use of a weapon or by means likely to produce death or great bodily harm.

Burglary—unlawful entry of a structure to commit a felony or a theft.

Arson—any willful or malicious burning or attempt to burn, with or without intent to defraud, a dwelling house, public building, motor vehicle or aircraft, personal property of another, etc.

Hate Crimes—murder; sex offenses; robbery; aggravated assault; burglary; motor vehicle theft; manslaughter; arson and other crimes involving bodily injury to any person in which the victim is intentionally selected because of the actual or perceived race, gender, religion, sexual orientation, ethnicity, or disability of the victim that are reported to university police authorities or local police agencies, which data shall be collected and reported according to category of prejudice.

Motor Vehicle Theft—the theft or attempted theft of a motor vehicle.

Liquor Law Violations—violations of laws or ordinances prohibiting: the manufacture, sale, transporting, furnishing, possessing of intoxicating liquor; maintaining unlawful drinking places; bootlegging; operating a still; furnishing liquor to a minor or intemperate person; using a vehicle for illegal transportation of liquor; drinking on a train or public conveyance; and all attempts to commit any of the aforementioned. (Drunkenness and driving under the influence are not included in this definition.)

Drug Abuse Violations—violations of state and local laws relating to the unlawful possession, sale, use, growing, manufacturing, and making of narcotic drugs. The relevant substances include: opium or cocaine and their derivatives (morphine, heroin, codeine); marijuana; synthetic narcotics (Demerol, Methadone); and dangerous non narcotic drugs (Barbiturates, Benzedrine).

Weapons Possession—violations of laws or ordinances dealing with weapon offenses, regulatory in nature, such as: manufacture, sale, or possession of deadly weapons; carrying deadly weapons, concealed or openly; furnishing deadly weapons to minors; aliens possessing deadly weapons; and all attempts to commit any of the aforementioned.
